# UNIVERSITY of HOUSTON MANUAL OF ADMINISTRATIVE POLICIES AND PROCEDURES

AREA: MAPP Policy

**SUBJECT:** Creating and Maintaining University Policies (Interim)

#### PURPOSE

This policy establishes processes and guidelines for developing, reviewing, approving, revising, and retiring University of Houston (UH) policies, known as Manual of Administrative Policies and Procedures (MAPPs).

# II. POLICY

UH aspires to maintain a policy framework that best serves its mission and implements legal requirements, Board of Regents policies, and System Administrative Memoranda (SAMs); and that represents and supports ethical conduct and compliance in all of its activities. This policy is intended to enhance operational efficiencies, best practices, shared governance, compliance, effective decision-making, and transparency with respect to the manner in which UH policies are developed and maintained.

#### III. DEFINITIONS

- A. Board: The Board of Regents of the University of Houston System (UHS).
- B. <u>Director of Policy Management</u>: The University of Houston Compliance Officer serving as the policy development facilitator whose responsibilities include: a) chairing the Policy Advisory Council (PAC), b) working with Subject Matter Experts (SMEs) to review and edit draft policies, c) addressing questions from the UH community regarding policy development, and d) otherwise managing the processing, dissemination, coordination of input from stakeholders, archiving, and review of MAPPs.
- C. <u>Full Review Process</u>: The process set forth in Section 5 for the review and processing of new MAPPs and Substantive Changes to current MAPPs (other than those designated as Legal Review, Interim Issuances, Housekeeping Changes and Minor Changes).
- D. <u>Housekeeping Change</u>: A revision to a MAPP that is clerical in nature and does not directly change meaning or intent of the policy. Housekeeping Changes include references to supporting law or other policies, corrected formatting or typos, corrected titles, change of authority for the policy, updated contact or URL information, or very minor text changes for clarity.
- E. <u>Policy Advisory Council (PAC)</u>: A standing committee of UH representatives involved in the policy development process. The PAC is comprised of the Director of Policy Management (who shall serve as its chair), a Faculty Council member appointed by the Faculty Council Executive Committee, and representatives from each of the following areas, as appointed by the President: Administration & Finance; Academic Affairs; Student Affairs; the Office of General Counsel; UH Compliance. The PAC shall meet monthly from August May, and as otherwise necessary.

- F. <u>Policy Office</u>: An office within the UH Office of Compliance and Ethics, which handles the policy development process for UH.
- G. <u>Responsible Party(ies)</u>: The supervisor primarily responsible for the subject matter of the policy. Depending on the subject matter, a MAPP may have more than one Responsible Party.
- H. <u>Subject Matter Expert (SME)</u>: The individual(s) designated by the Responsible Party(ies) as the curator of the MAPP and the first point of contact to answer policy questions. The SME is the employee(s) with working knowledge of the MAPP or direct (or "hands on") responsibility for the implementation of the policy.
- I. Substantive Change: A revision to a MAPP that materially alters its meaning or intent.
- J. <u>University Coordinating Commission (UCC)</u>: The UH committee established pursuant to MAPP 01.01.02 that facilitates discussion across the university community during the policy development process.

#### IV. AUTHORITY AND SCOPE

- A. MAPPs are intended to be governing principles that implement legal authority, Board or System policies or that establish uniform rules and procedures on matters of overall UH concern not addressed in Board policy or in a SAM. This Policy does not apply to policies and procedures that, by their purpose and scope, apply only to a specific college or administrative unit within UH.
- B. The President delegates to the UH Compliance Officer the responsibility and authority for the development, processing, communication, archiving, and retirement of MAPPs through the establishment of a Policy Office within the Office of Compliance and Ethics.
- C. Board policies and SAMs take precedence over MAPPs. To the extent that a MAPP conflicts with Board policy or a SAM, the conflicting language shall be void and the MAPP at issue will be retired or revised to bring it into compliance with the SAM. See <u>Board Policy 01.01.5</u> University Policies.
- D. In the event of a conflict between a MAPP and any law or regulation promulgated by a higher authority (e.g., federal or state law, regulation of an administrative body with oversight), the higher authority will govern, and the MAPP at issue will be retired or revised to bring it into compliance with the law or regulation at issue.
- E. In construing policies, compliance with Board policy, SAMs, and higher legal authority is presumed to be intended.

### V. POLICY DEVELOPMENT, REVIEW, APPROVAL, RETIREMENT AND ARCHIVING

# A. New Policies.

 Should a Responsible Party determine a need to propose a new MAPP, the Responsible Party or their delegate shall consult with the PAC to determine if a MAPP is the appropriate policy mechanism, consistent with sub-paragraph 2 below.

- 2. <u>Policy Characteristics</u>. Policies should be governing principles that have broad application or effect across UH, and:
  - a. seek to ensure compliance with applicable Board policy, SAM, law or regulation,
  - b. establish fundamental operational, administrative or budgetary principles,
  - c. support UH's mission and goals,
  - d. promote consistency, efficiency, and effectiveness or reduce institutional risk, or
  - e. provide procedural, administrative or business guidance where necessary for the university community.
- 3. If appropriate, the Responsible Party shall assume the responsibility of preparing a draft document and shall designate one or more SMEs.
- B. <u>Formatting</u>. The standard template should be used for all MAPPs. The policy should be drafted in such a way as to be understandable, concise and easy to navigate.
- C. Revising Policies: Existing MAPPs may be revised at the regular review period as specified in the policy, or may be revised upon a determination by the Responsible Party of the need to update the information in the MAPP. The Responsible Party or their delegate shall assume the responsibility of preparing draft revisions as a redlined version of the existing MAPP.
- D. <a href="PAC Review and Assistance">PAC Review and Assistance</a>. As an integral part of the policy development process, both new MAPPs and revisions to existing MAPPs (other than those involving Legal Changes, Housekeeping Changes, and Interim Issuances) will be reviewed by the PAC. The PAC will assess the policy to evaluate whether the draft is sufficiently developed to the point that it is ready to be disseminated to the UH community for feedback.
  - The PAC will assist SMEs in identifying issues to address before a MAPP is disseminated to the UH community for feedback, recognizing groups that will be affected and the need to incorporate the input of various constituencies, and identifying intersections or conflicts with other policies.
- E. <u>Communication</u>. Unless circumstances necessitate an expedited process (see Section 6 below), drafts assessed by the PAC as ready for dissemination will be communicated to the UH community via the MAPP listserv, posted electronically on the UH policy website, and communicated in such other manner as the PAC may recommend to reach the broadest UH audience in light of the scope and content of the draft.
- F. <u>UH Community Review</u>. The comment period for new MAPPs and for Substantive Changes to existing MAPPs will be for a period of thirty (30) calendar days from the date of dissemination, during which time members of the UH community, which include faculty, staff, students, executives and the UCC, have the opportunity to submit written feedback that will be delivered to, and considered by, the SME.
- G. <u>Updated Draft</u>. Once the comment period has closed, all written feedback received will be forwarded by the Policy Office to the applicable SME who will take all comments received from the UH community under advisement and implement such changes evaluated and

- considered by the SME as necessary or appropriate. The SME will prepare an updated draft to provide to the Policy Office for electronic posting and for submission to the Office of General Counsel.
- H. <u>Legal Review</u>. All new MAPPs and changes to existing MAPPs (with the exception of Housekeeping Changes) must be reviewed and approved for legal sufficiency and clarity by the Office of General Counsel prior to adoption, and shall be updated as necessary. Once the MAPP has undergone legal review, the final version of the MAPP will be transmitted by the Office of General Counsel to the Policy Office for final processing.
- Policy Adoption. A MAPP is approved and considered official UH policy after approval by the Office of General Counsel, the Responsible Party(ies), the appropriate Vice President, and the President.
- J. <u>Distribution and Publication</u>. The Policy Office will coordinate the distribution of new policies and policy revisions by communication through the MAPP listserv. New policies and policy revisions shall also be published electronically on the UH website, communicated to the UCC, and distributed as otherwise required by law. In addition, the Responsible Party or their designees will determine if other effective methods for policy dissemination should be undertaken and if training should be conducted.
- K. Retirement of a Policy. A MAPP is to be retired when it is no longer needed or is more effectively combined with or superseded by a SAM or another MAPP. A MAPP is considered retired upon documented approval by the Responsible Party, the Office of General Counsel, the appropriate Vice President, and the President. Alternatively, a MAPP may be retired per Section VII.B. Failure to Conduct Periodic Review, below. Upon retirement, the Policy Office will remove the MAPP from the UH website and archive it.
- L. <u>Archiving</u>. When a MAPP is revised or retired, the Policy Office will maintain the prior or retired version(s) in its electronic archives.

# VI. EXPEDITED REVIEW

- A. <u>Legal Changes</u>. Certain information within an official MAPP may become obsolete or require revision due to changes in legislation or other higher authority. Additionally, legal authority may require that the Board, Chancellor, or President implement or approve certain policies to comply with federal or state law. When such information is not open for interpretation or debate, the document will not be subject to the Full Review Process. Instead, the PAC and the UCC shall be notified as a courtesy, and the document will be revised in consultation with the Vice President for Legal Affairs/General Counsel and submitted directly to the Responsible Party(ies), the appropriate Vice President and the President for approval. The revised policy shall then be distributed as indicated in Section V.J. above.
- B. <u>Minor Changes</u>. If an SME desires to modify an existing MAPP in order to reflect a minor improvement or update to a process or procedure, or to better align the MAPP with other MAPPs, SAMs, or Board policy, such changes will be processed by the Policy Office on an expedited basis, but only to the extent such proposed changes (as determined by the PAC upon review) do not affect the purpose and meaning of the MAPP and no amount of feedback will negate the need for the change. Revisions processed by the PAC on this basis shall be submitted to the Responsible Party(ies), the Office of General Counsel, the appropriate Vice President, and the President for approval. The revised policy shall then be distributed as indicated in Section V.J. above.

- C. <u>Housekeeping Changes</u>. The Director of Policy Management, in consultation with the MAPP's SME, has the authority to make non-substantive, housekeeping changes to a MAPP without the necessity of going through the Full Review Process. The PAC and the UCC shall be notified as a courtesy of any housekeeping revisions, and the document will be submitted directly to the Responsible Party(ies), the Office of General Counsel, the appropriate Vice President, and the President for approval.
- D. <u>Interim Issuances</u>. When a new MAPP or revisions to an existing MAPP are needed in a timeframe that does not allow for the Full Review Process due to a regulatory, accreditation, or other pressing need, it can be proposed as an interim policy, which shall be implemented on an interim basis with notice to the PAC and the UCC. Revisions on this basis shall be submitted to the Responsible Party(ies), the Office of General Counsel, the appropriate Vice President, and the President for approval. The policy shall then be distributed as indicated in Section V.J. above. The interim policy must undergo the Full Review Process as soon as practicable.

# VII. RESPONSIBILITIES

- A. <a href="Periodic Review">Periodic Review</a>. The Responsible Party, by and through the SME, is responsible for maintaining and updating MAPPs in their area to ensure that they reflect current policy and practices and that they conform with applicable laws and regulations. To ensure policies remain current, all MAPPs should undergo a periodic review at least once every five years, or more often if required by law or circumstances. If such a periodic review does not result in changes, the SME and Responsible Party will confirm to the Policy Office that the MAPP has undergone review and is current, and the MAPP documentation will be updated to reflect the most recent review date.
- B. Failure to Conduct Periodic Review. The Director of Policy Management will notify the PAC if they determine that the Responsible Party, by and through the SME, has not made good faith efforts to maintain or update MAPPs in their area in accordance with Section VII.A. The PAC will review the applicable MAPP and determine if the MAPP should be retired because it is no longer needed or is more effectively combined with or superseded by a SAM or another MAPP. If the PAC determines that a MAPP should be retired, the Director of Policy Management will advise the SMEs, Responsible Party, Office of General Counsel, and appropriate Vice President of the same, and the MAPP will be considered retired upon the documented recommendation of the PAC and approval by the Office of General Counsel, the appropriate Vice President, and the President.
- C. <u>Enforcement and Monitoring</u>. UH Vice Presidents are responsible for promoting and enforcing the compliance of all MAPPs within their area of oversight.
- D. <u>Compliance</u>. Faculty, staff and students are responsible for knowing, understanding and complying with MAPPs that relate to their position, employment or enrollment at UH. Responsible Parties are responsible for following the policy development and implementation process established by this policy, communicating their policies effectively, reviewing and updating their policies regularly, and monitoring their policies for compliance and effectiveness.
